

Minutes of the Meeting of the Board of Directors of the Ruby Forest Homeowners' Association June 13, 2023

The meeting of the Board of Directors was called to order at 6:30 p.m. by Kevin Maguire, 2022-2023 President. Board members present were: Blake King, Vice President; Cindy Powell, Secretary; Micah Seehorn, Treasurer; Sally Watson, and Joseph Hinton. No residents were present to discuss neighborhood issues.

The meeting was opened by Kevin Maguire at 6:30pm.

Homeowner's Forum

- 6 homeowners were present to initiate questions at the homeowner's forum.
- Mike Ringham provided Report on vending machine, and discussed repairs needed.
- Allowing homeowners to have poultry was discussed, it would be prohibited.
- Size of trees requiring ARC approval to be removed was discussed. Erosion control is key component
 of approval process for removing trees.
- Running a business from home discussed, violations and fines will come from property management.
- Requiring new owners to join HOA was discussed. Property management must be involved to require
 HOA membership when new owner moves into community. This has been investigated in the past and
 it is difficult to implement.
- Several home owners expressed concern over how rental properties in RF are currently being maintained. Changing by-laws was discussed. It will require going door to door for votes. Residents expressed concerns about cars parked in the street overnight, number of cars parked at rental properties. Capping rentals was discussed. Providing incentives for joining HOA was discussed.
