

Minutes of the Meeting of the Board of Directors of the Ruby Forest Homeowners' Association July 12, 2017

The meeting of the Board of Directors was called to order at 6:30 p.m. by Rosa Brown, President. <u>President's Report</u> was given by Rosa Brown noting the tasks completed by the Board and work-in-progress since the May meeting as follows:

- 1. Net rental income from the Clubhouse for the month of June was \$245
- 2. Received roof inspection/completion from the City of Suwanee. Authorized payment to roofing contractor for \$6,791
- 3. Brick wall repair made to the pool pump room \$4,100
- 4. Repaired security camera for the pool area \$150
- 5. Replaced 2 nets on the upper tennis courts \$350
- 6. Replaced 4 contactors at the upper tennis courts with 6 hours of labor for \$870
- 7. July 4th party food, cooks, games, prizes and jumpy expenses were \$1,042

 Reviewed and discussed bids for painting the interior walls and ceiling that were damaged by water from the roof leak. A vote was taken and the board unanimously approved a bid for \$2,050. This also included pressure washing the exterior.
